Please take note of the following in terms of the impact of the above on the existing qualifications framework.

New Qualifications:

Where providers are interested in offering any of the new qualifications, the normal programme submission processes for evaluation and approval will be applicable.

Replacement Qualifications

Where a listed qualification replaces an existing qualification, the registration date of the revised qualification simultaneously becomes the de-registration date of the qualification that such a newly registered qualification is replacing. (Please check the dates of registration of the new qualifications to ensure you are aware of any de-registration dates which affect you.)

In this event, providers with such a programme approved for their scope of provision has one year after this date to conclude learner registration and the N plus 2 principle also automatically becomes applicable. In this event an additional year for training out is applicable to a certificate level qualification whilst an additional two year period for training out applies to a diploma level qualification.

It is advised that providers submit applications for programme evaluation and approval for such qualifications within the period of finalised learner registration as to enable a smooth transfer between their existing and envisaged scope for provision.
